RE: Long-term disability and WorkSafeBC pension time credit settlement

If you are a CUPE member and were on a WorkSafeBC claim recently or dating as far back as 2013, you may be eligible for additional pensionable hours.

This notice has been issued as part of the implementation of the settlement between BCEHS and APBC of Policy Grievance re: Long-term Disability/WorkSafeBC Pension Time Credit.

Please note that if your employee ID is identified in the list below, you are an employee who may not have been credited with pensionable service during your WSBC claim period.

In order to ensure that you are appropriately credited with pensionable service while receiving WSBC benefits, you must have an approved LTD claim for the period you were on a WSBC claim.

BCEHS and APBC have agreed upon the following process:

- Within three months of today, BCEHS will send LTD packages to all employees who have been identified as potentially missing pensionable service because they were on a WSBC claim and did not apply for long term disability.
 - The LTD package will be sent out by the Disability Management team at PHSA via email. Please ensure that you are watching your email for this package.
- Once you receive the LTD package, you will be required to complete your sections of the application and collect the relevant medical records. There are several ways to obtain your medical records:
 - You can contact WorkSafeBC via phone and inform them that they can release your medical records to you in order for you to provide these to Canada Life. Please note this option has no cost; or
 - Your physician can complete a physician's statement or provide you the medical documentation from the time of your illness or injury;
- Once the LTD package is complete, you will need to submit it to Canada Life. Please note
 that the package will provide you with a specific email address to send your paperwork to,
 ensure you carefully read the paperwork.





- Once BCEHS is informed of Canada Life's approval, BCEHS will credit you with pensionable time, as applicable. At that time, BCEHS will report your pensionable service to the Public Service Pension Plan. You will not be eligible for LTD benefits since you are/were in receipt of WSBC benefits.
- BCEHS will also ensure any adjustments required for your Supplemental Pension (RSRP) are also corrected through this process, as required.

This process will be a lengthy one; it may take 18 to 24 months for Canada Life to make a decision on your individual claim. If you are close to retirement or have any questions or concerns in the meantime, please reach out to disabilitymanagement@phsa.ca.

If you were on a WSBC claim for over six months, anytime between 2013 to now and did not complete the Canada Life paperwork and you do not see your employee ID on this list, please reach out to APBC at info@apbc.ca.
